Subject: Child Nutrition Database Release 17

The Child Nutrition Database Release 17 (CN17) was made available at the Healthy Meals Resource System website on August 5, 2013. Computer software companies with software approved by the Department of Agriculture (USDA) for Nutrient Analysis are required to update their software with CN17. This release can be downloaded by visiting: <http://healthymeals.nal.usda.gov/cndatabase.html>.

The CN Database is an integral part of the nutrient analysis software approved by USDA. We expect software companies with USDA-approved software to incorporate CN17 into their products and to make the new version of the software available to current users no later than November 8, 2013. Anyone who does not receive an update with the current CN Database by November 8, 2013 should contact his or her software company.

The following chart provides a snapshot of the content of CN17 and a summary of new and updated items:
